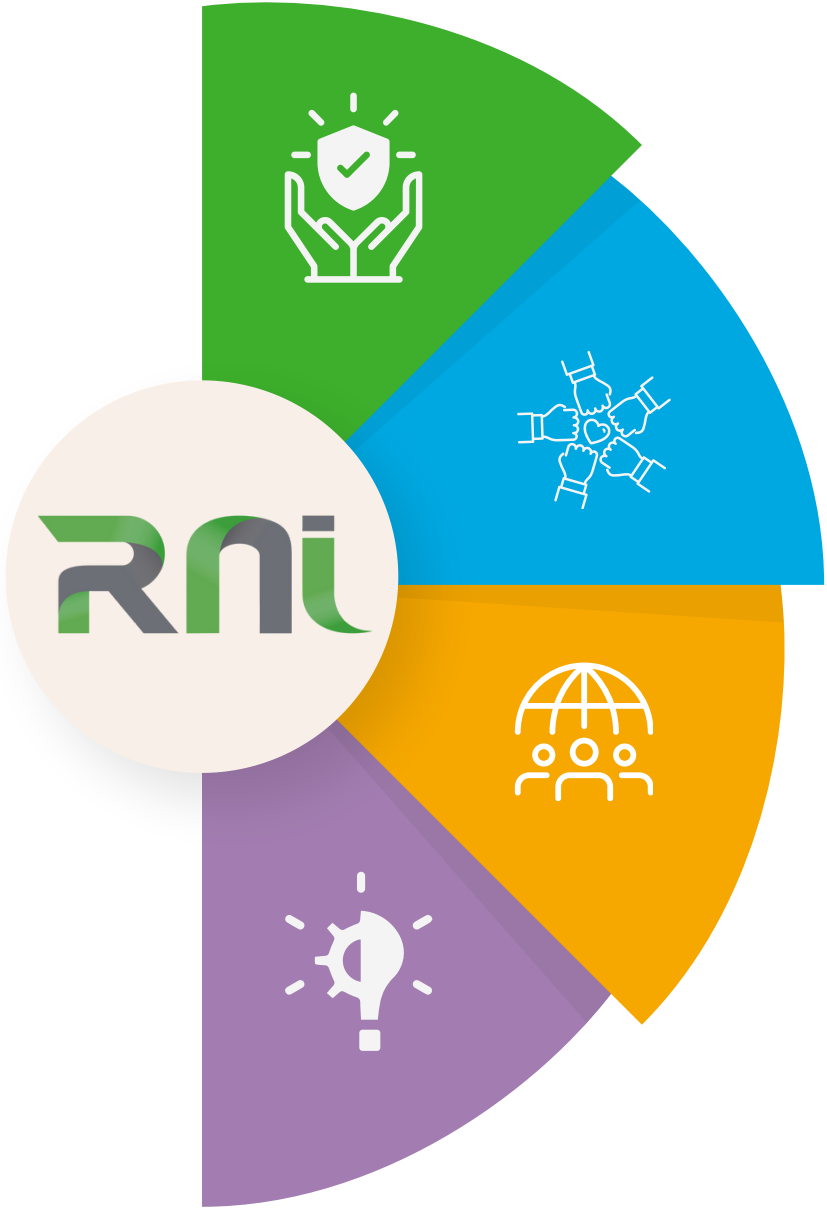

ZERO BY 2035

The International Energy Agency (IEA) states that all advanced economies must achieve zero carbon electricity by 2035. This is now reflected in UK Government policy. Northern Ireland has one of the greatest wind resources in the world and is well positioned to meet this target.

80 BY 30

We currently have a 1.8GW renewable capacity. The NI Climate Change Act set a target of 80% renewables by 2030. This will require more than doubling the renewable electricity generation to meet the growth in demand as we electrify heat and transport.
